What is this campaign about?	This GXBank QR Cashback Campaign (" Campaign ") is organised by GX Bank Berhad (" GXBank ") in collaboration with Payments Network Malaysia Sdn Bhd (" PayNet ") and will run from 6 May 2025 to 5 August 2025 (both dates inclusive) or upon reaching the Maximum Cap , whichever is earlier, or as otherwise determined by GXBank with prior notice (" Campaign Period "). <u>Important Note</u> : This Campaign has a maximum limit of RM500,000 throughout Campaign Period (" Maximum Cap "). There are three (3) campaign months as follows, as referred to as ' Campaign Month'):

When will I receive the campaign reward?	 This Campaign Reward will be credited to the Eligible Customer's GX Account by the end of the following day, after the Eligible Customer has successfully completed the Qualifying Criteria Note: In exceptional cases, crediting of the Campaign Reward could take up to two (2) weeks after completion of the Qualifying Criteria. If an Eligible Transaction is cancelled, voided, refunded, or otherwise deemed invalid, the corresponding cashback will be reversed and debited from the Eligible Customer's GX Account, regardless of whether the cashback has already been credited
